General terms and conditions

1. Scope

These general terms and conditions shall apply to the realisation of the corporately organised international conference by the IRM, CDMH and the IIP.

2. Registration

Registrations are considered in order of contact and will be confirmed afterwards. If the entire conference fee is paid at the due time, the applicant obtains the right to participate at the specified events of the conference. If the applicant does not participate in parts of the conference enrolled and paid for, they cannot deduce any financial recompense from the organizers.

3. Cancellation of the definite registration

A cancellation of a confirmed registration must be made until 4 weeks prior to the start of the conference and will incur an administrative charge of 20 EURO.

4. Cancellation, adjournment of events of the conference

In the event of an act of God, natural catastrophe, war, etc. making impossible the realisation of the conference, the organizers have no requirements in respect to participants. The conference fee will however be refunded in full.

5. Costs

The conference fee must be paid within 14 days after the invoice. Deferred payment is possible. The conference fee does not contain, unless there has been prior agreement, any perquisite as to the provision of accommodation, travel costs, catering, etc.

With the signature of the registration form, participants obligate themselves to pay the appropriate conference fee in full and in due time. If the conference fee is not paid in due time, the organizers are not obligated to admit the participant to the conference.

6. Participation at events

If specified presenters cancel or certain events within the conference are cancelled (for example, due to speakers being indisposed by illness) there is no requirement for recompense to be made by the organizers.

7. Accountability

The organizers exclude any accountability for any adverse events such as theft during the period of the conference. The participants are responsible for their own insurance coverage.

9. Place of jurisdiction

The place of jurisdiction is Olten (Switzerland), the domicile of the HSA.
